Can I import products from Russia?

What are Russia's export restrictions?

Export restrictions to Russia have increased, especially in response to international sanctions. Prohibited or regulated items include: Advanced technology products: High-tech items like quantum computers, advanced semiconductors, electronic components, and software are banned to curb technological advancements in strategic Russian industries.

How much does the EU export ban affect Russia?

58% of pre-war imports are covered by the measures, representing EUR91.2 billion. The total value of export restrictions on business services is EUR3.28 billion (16% of EU's exports prior to the invasion). The export ban on EU technology items has made Russian technology-intensive industries shrink.
