What happens if a solar panel is damaged?

Claims for damaged solar panels would also vary based on your insurance plan, but likely follows the same process as other damaged property claims. If you subscribe to a PPA or lease your solar panels, a third party owns your system and is responsible for damage and maintenance.

Does home insurance cover solar panel damage?

When you file a home insurance claim for solar panel damage, you'll be covered under one of two home insurance coverages (dwelling or other structures) depending on whether the panels are attached to your home or not. You'll need to pay your policy deductible before your insurance provider pays out for the damage.

How much does solar panel insurance cost?

The solar panel insurance cost will depend on various things like your location, your current coverage amount, the size and cost of your system, and your insurance company's plan. Claims for damaged solar panels would also vary based on your insurance plan, but likely follows the same process as other damaged property claims.

Are rooftop solar panels covered under Home Insurance?

In most cases, rooftop solar panels are covered under home insurance. If they are attached to the main part of your home or an attached structure like your garage, they would be covered under your policy's dwelling coverage.
